We write with several updates on a number of key matters for you to consider and share as appropriate with your teams. We hope you find this information helpful.

# **COVID-19 vaccination programme**

By Sunday 24 January, it is expected that all residents and staff in all older adults' care homes in Leicestershire will have been offered a COVID-19 vaccination, and have had it administered where they consent. The exception to this is where a risk assessment has determined that it is not safe for the vaccination team to carry them out in a specific care home, such as in the event of a significant outbreak.

Bulletin 69 describes how care home workers who have not yet accessed their vaccination for any reason can still receive their jab. This is an ongoing entitlement and will not cease for the foreseeable future. To maximise safety within a care home it is critical that as many staff as possible are vaccinated against COVID-19 and we appreciate your efforts in answering your colleagues' queries about the vaccine, and showing leadership in this area. The LLR vaccination programme is now moving on to wider groups of social care staff (cohort 2), as described in the Standard Operating Procedure at <a href="https://www.england.nhs.uk/coronavirus/publication/vaccinating-frontline-social-care-workers/">https://www.england.nhs.uk/coronavirus/publication/vaccinating-frontline-social-care-workers/</a>. Invitations are being sent to providers based on prioritisation of service type, with a target of reaching all face-to-face social care workers by the national deadline of 15 February. At present, the appointments available are through the hospital hubs – unfortunately we are not yet able to offer vaccinations at other locations, but Primary Care Networks are also rolling out their plans in parallel, and we will be exploring ways to make appointments available in locations which are as convenient as possible.

Leicester City Council is offering a webinar about the vaccine, which is open to the public, and which your staff may find valuable. The details are:

## **COVID-19** positive discharge process

The current guidance relating to testing for COVID-19 advises that all patients must receive a COVID-19 PCR test results within 48 hours prior to discharge. Anyone who tests positive should then complete a period of self-isolation and should not be tested again for a further 90 days. Those patients that have tested positive in hospital, have completed their isolation period and then require discharge to a care home will not need to be retested again on discharge if this falls within 90 days of the last positive test.

The national guidance for care homes currently advises that to minimise the risks 'all residents being discharged from hospital or interim care facilities to the care home, and new residents admitted from the community, should be isolated for 14 days within their own room'. All patients that have tested negative for COVID-19 in hospital must have a 'time-stamped reported COVID-19 test result' which must be communicated to the care home prior to the person being discharged from hospital.

The guidance makes no reference of the requirement for a patient to have a negative COVID-19 test result prior to discharge from hospital and admission into the care home.

## **COVID-positive 'designated settings'**

You will be aware from guidance released in October 2020 and recently confirmed in guidance last week (<a href="https://www.gov.uk/government/publications/designated-settings-for-people-discharged-to-a-care-home/discharge-into-care-homes-for-people-who-have-tested-positive-for-covid-19">https://www.gov.uk/government/publications/designated-settings-for-people-discharged-to-a-care-home/discharge-into-care-homes-for-people-who-have-tested-positive-for-covid-19</a>) that anyone with a COVID-19 positive test result being discharged into or back into a registered care home setting must be discharged into an appropriate 'designated setting' and cared for there for the remainder of their required isolation period.

We urgently need extra capacity for 'designated settings' for COVID-positive discharges from hospital. UHL, and hospitals in neighbouring areas, are seeing significant increases in COVID-positive admissions and corresponding increases in those who are medically fit for discharge, but are unable to return home and need to complete their isolation period in a designated care home setting.

#### **Lateral (Rapid) Flow Tests**

1 in 3 individuals with COVID-19 do not show symptoms and are unaware that they might be spreading the infection – Lateral Flow Tests (LFT) can help identify these individuals. Once identified, we can trace contacts, and help prevent the virus spreading to others.

In response to Leicestershire care home staff queries about LFT, Public Health has produced a <u>factsheet</u> as a useful guide to some of the most common questions about lateral flow tests for your information and to pass to your teams.

#### **Rapid Testing Fund**

The Government's Rapid Testing Fund has been set up to support Lateral Flow Testing of staff in care homes. The fund also supports visiting professionals to enable indoor, close contact visiting where appropriate.

Leicestershire will receive £1.66m of the £149m national Rapid Testing Fund. Around 80% must be issued directly to care homes on a 'per bed' basis – this is known as the 'mandatory' part of the fund, and is equivalent to approximately £250 per bed.

The local authority has discretion to use the remaining 20% of funding (the 'discretionary' part of the fund) to support the care sector to operationally deliver LFT testing.

All funding must be spent by the end of the fund period on 31 March 2021 and any funding that remains unspent at this point will need to be returned to the council.

The measures eligible for funding from the 80% mandatory part of the grant are:

- Paying for staff costs associated with training and carrying out LFT testing
- Costs associated with recruiting staff to facilitate increased testing
- Costs associated with the creation of a separate testing area where staff and visitors can be tested and wait for their result
- Costs associated with disposal of LFT tests and testing equipment

Monthly reporting is a grant condition and will be integrated with the reporting on ICF2 to make it as straightforward as possible for providers.

# PCR testing for home care workers

Regular testing for home care staff is important because it:

- identifies home care workers who currently have COVID-19 so they are able to self-isolate if positive
- protects those receiving care from infection passed to them by home care workers who are confirmed positive
- prevents and controls the spread of the virus by identifying asymptomatic cases

Home care agencies are responsible for ordering and distributing test kits to all home care workers for them to conduct at home on a weekly basis. Guidance on PCR testing for home care can be found

## Infection control fund (ICF)

Care homes should receive their second ICF2 payment on Monday 25 January. With this payment, the allocated sum for care homes of almost £3.5m will have been distributed. The sum paid on Monday equates to £400 per bed, which in addition to the initial payment of £339 per bed means that £739 per bed has been paid. Some homes did not submit a report, or reported an underspend in ICF1 and those monies have been deducted from this payment.

Community providers should receive their second ICF payment on Wednesday 27 January. The sum paid equates to £240 per client. Again, some providers did not report or reported an underspend in ICF1 and those monies have been deducted from this payment. With this sum almost £1.2m has been distributed, which is less than the allocated sum of £1.47m. The reason for this reduced level of grant is that whilst an initial payment totalling over £700k was made in October, total expenditure for October to December was less than £400k, and the DHSC expectation is that the whole sum should be spent. The expected total spend reported for October to March is less than £1.0m. The grant conditions require unspent monies to be returned, so rather than making payment now to be retuned in April, the council is temporarily reserving the balance - where providers subsequently submit their report, we will be pleased to release the balance to them.

The December reports show there are care homes and community providers that are reporting expenditure in excess of the grant that they have received. The council is exploring ways to redistribute unspent monies to those providers to mitigate their costs and ensure that as much grant money as possible is spent in Leicestershire.
