### 11 November deadline for full vaccination for care home workers



The deadline for care home staff to be fully vaccinated is fast approaching.

Care home staff, and those entering care homes to work (including agency staff) or volunteers need to have received both doses of the vaccination by 11 November when new government legislation comes into force.

Workers yet to receive their second dose should already have an appointment booked. Please ensure staff can attend their appointments and if they have had to cancel, that they have been able to rebook.

## Visiting professionals, tradespeople and volunteers entering care homes

You will recall that within [bulletin 102](#) we shared template wording to use or adapt for communication with the relevant organisations who will be entering your home from 11 November.

The DHSC has produced a similar letter for care home providers to share with visiting professionals, tradespersons, and volunteers about the new regulations. The letter outlines who the policy does and does not apply to, how individuals can evidence vaccination exemptions and what the role of a registered person in CQC registered care homes is when implementing the policy.

## Verifyplus for care homes

Leicestershire County Council, Leicester City Council and Rutland County Council have supported the development of an app by EMCARE to assist with the recording and management of people entering the care home as fully vaccinated or exempt. All care homes within Leicestershire have been given 6 months free access to the Verifyplus app, from 11 November 2021.

## COVID-19 vaccination boosters

The Department of Health and Social Care has released a statement announcing that COVID-19 booster vaccines can now be given sooner than six months after the second dose to certain people who fall under the at-risk category, where their vaccination makes operational sense. ## Flu vaccination available to book online

Adult social care staff providing face-to-face services are eligible to receive a free NHS flu jab and can book theirs today. We strongly urge you to encourage your staff to take up the offer of a free flu vaccination as soon as possible.

Flu jabs are being given at:

- Local GP surgeries
- Midwifery service if the recipient is pregnant

This year, due to the COVID-19 pandemic, it's more important than ever to prevent the spread of flu and avoid the danger of contracting both flu and COVID-19.

Getting the vaccine will help to protect staff, their family, and the people they care for from getting the flu. Vaccination helps to keep social care services running and reduces the burden on the NHS during the winter.

Alongside the COVID-19 vaccinations, having the flu jab can help to build the best defence this winter. If offered both the booster and flu vaccines, it's safe to have them at the same time.

## **Leicestershire and Rutland DHU urgent falls response service**

From 11 October 2021, EMAS and health and social care professionals been able to refer patients to a new urgent falls response service, which will run for a pilot period of at least six months, during which regular service review and evaluation will take place.

This new service is for patients who are resident in the county of Leicestershire or Rutland who have fallen on the floor and cannot get up, and who have no suspected serious injury. There are two falls response vehicles based at Oakham and Loughborough. Each vehicle is staffed with a clinician and a health care assistant and is equipped with lifting / patient handling equipment, along with medications commonly used in urgent care. The service is delivered by DHU Health Care.

### *Who can refer?*

- EMAS
- 111
- Nursing and residential care home staff
- GPs and staff based within practices including practice nurses
- Health visitors
- Midwives
- Community nurses
- Adult social care workers
- Home care workers
- Community occupational therapists and physiotherapists
- Social prescribers
- Care coordinators

### *How to refer*

Referrals are currently accepted between 8.00 and 20.00, Monday to Friday. To refer a patient please telephone 0116 295 0095. Please note this number is not for public use.

Phase 2 of this pilot will see the inclusion of weekend service provision – further information will be available shortly.

### *Referral criteria*

All patients residing within Leicestershire and Rutland who have fallen and are unable to get up either independently or with assistance of bystanders.

### *Exclusion criteria*

The below list are examples of patients not appropriate for the service. Cases will be triaged on an individual basis and this list is not exhaustive:

- Anyone in a public place
- Anyone no longer on the floor
- Patients located outside of Leicestershire county and Rutland (including Leicester city residents)
- Head injury and on anticoagulants
- Obvious bony injury
- Severe uncontrolled haemorrhage
- Witnessed loss of consciousness at any time pre or post fall
- Signs of cerebrovascular accident / stroke or seizures as a consequence of injury
- Fall from height above 2 metres

There may be occasion where exclusion criteria may apply, however, if it is clear from the Respect form or advanced care plan that the patient is not for admission then a referral may still be made and our clinician will assess whether a visit is appropriate.

In the absence of a Respect form or advanced care plan a health care professional / EMAS may refer if they believe a visit may be in the patient's best interest. The service's clinician will assess whether a visit is appropriate.

### *What happens when a patient is referred?*

- A non-clinical member of staff will take demographic details and ask a number of questions
- A clinician will review the referral within 15 minutes to ensure the referral is safe and appropriate. Where necessary they will call the patient / referrer to clarify any information
- The service aims to visit appropriate patients who have been referred within 2 hours. Once the clinician is satisfied that it is safe to do so, the team will assist the patient off the floor and carry out any further assessments as required
- If there are any underlying medical problems or any injuries these will be treated and managed as appropriate. The clinician will make any onward referrals as required
