# Fit test operator training

The Leicester Leicestershire & Rutland Local Resilience Forum (LRF) are offering free training for providers across LLR who are conducting aerosol generating procedures and therefore need to use FFP3 masks.

This Fit Test Operator Training course is aimed at those who, as part of their role have responsibility to manage or conduct Fit Testing in the workplace.

Course content includes:

- Regulations and guidance
- The purpose and applicability of Fit testing
- Procedures for selection of adequate and suitable RPE
- Fit factors and protection factors
- Set up and diagnostic checks

- Examination procedures for RPE, identification of maintenance problems
- Correct donning procedures and pre-use fit checks
- Fit Test procedures and purpose of the Fit test exercises
- Capabilities and limitations of the Fit Test equipment
- Troubleshooting & problem solving

# 'Dose 1' care home worker vaccinations

To ensure that COVID-19 vaccinations are as convenient as possible for the workforce, we have arranged for a vaccination team including a doctor, nurses and health care assistants to visit Leicestershire care homes on Tuesday 30 March for workers wishing to have their first vaccine dose.

Slots for these visits are strictly limited - if you would like to be considered please contact <u>enquirylinequality&contracts@leics.gov.uk</u> by 9.00 on Monday 29 March with the number of workers consenting and able to have their first dose on that day. We will be in touch to let you know whether a visit will be possible. Please note that this offer is only available on Tuesday 30 March for workers wishing to have their first dose.

We reported in the last bulletin that dose 2 visits have begun in care homes; please make every effort to encourage staff to be available for their second dose when the vaccination team visits.

#### Home care testing

Home care testing results recorded are lower than expected - providers have reported care professionals are finding it easier to attend local test centres rather than carry out home test kits and, in some cases, are not carrying them out at all. It is important that we encourage staff to undertake these tests and to register to support the national effort in controlling this virus.

It is important that we support our care professionals in this additional ask, to guide and help them understand the reasons for testing to include the benefits that impact both professionally and personally and the vital part that testing holds in keeping people safe. We know that providers are already supporting the home care testing process – here are some ideas which many of you are already using to encourage participation:

- Supervisions and one-to-ones to address individual concerns and difficulties that staff may have
- Team meetings to discuss the process of taking the test, allowing staff to share experiences
- Offering help to coordinate the taking and registering of the tests for those staff which require additional support within the workplace
- Weekly reminder to staff including re issuing or your Unique Organisation number for registering (UON)

- Await care reviewed at point of receipt at 9.00 and 13.00 with offers being submitted to brokerage by return
- Start dates to be at the earliest opportunity
- Offers of care to be prioritised by Hospital Discharges / HART transfers / community packages

# Funding update

#### ICF2

The overspend payments, funded from the ICF2 Discretionary Fund, have been calculated by using the reported expenditure for the 4 months to the end of January to project expected expenditure to the end of March.

Care homes reporting average expenditure below £995 per bed and community providers reporting average expenditure below £504 per client will receive full payment of the projected overspend. Providers reporting higher average costs than those will see the overspend payment capped. The cap has been set at 150% of the cost per client / bed set out in the funding guidance. By capping the overspend payment we are able to pay more money to more providers that are operating more cost effectively.

A number of providers, mainly in the community, are reporting underspends and so may have to refund those monies - more information will follow in a future bulletin on our approach to those.

#### Workforce Capacity Fund

Vaccination payments have been issued to community and residential providers, equivalent to £20 per vaccinated employee. Those payments will arrive in provider bank accounts by 31 March.

#### DHSC announcement

Further funding to support infection control and testing from April onwards was recently announced - we await further information and will keep you informed.
