

## Ofsted publications during pre-election period

See below for information about what Ofsted have said they will publish during the pre-election period running from November 6 to December 13 2019.

During the pre-election period, we'll be publishing less content, in line with <u>Cabinet Office guidelines</u>. We will delay planned publication of research reports until after the election, along with the texts of speeches, press notices and news stories. We're moving the launch of our Annual Report to January. We will not be publishing reports on:

inspections of local authority (LA) children's services (ILACS) joint targeted area inspections (JTAIs) local area special educational needs and disabilities (LA SEND) provision LA-run children's homes LA-run further education and skills (FES) provision fostering or adoption agencies that have had functions delegated to them by a local authority All other inspection reports will be published, which includes all schools and early years providers, including LA-maintained schools as well as non-LA FES providers. During this period we will continue to publish pre-announced official statistics (ONS), but our management information releases will be suspended until after the election.

#### Drone use

From November 30 2019 those wanting to fly drones will have to have passed an online theory test and registered as an operator; failure to do so can result in a fine of up to £1000 under new regulations from the Civil Aviation Authority (CAA). The new regulations apply to anyone wanting to fly a drone or an unmanned aircraft weighing 250g or above. A unique registration number will be issued which must be displayed on each aircraft and which should be visible from the ground.

The drone code of conduct says that pilots should stay at least 150m from built-up and busy areas, including schools. They should also be in sight of their drone at all times, so it may be possible to identify who is flying it. As a general rule, no one should be flying a camera-equipped unmanned aircraft (drone) within 150m of a 'congested area' – which includes a school. Flying over a school can give rise to Safeguarding. If you have any concerns about unmanned aircraft being used around your school, either from a safety or privacy perspective, contact the police on 101, with the drone's registration number if possible.

Also, from September 2020 it will be compulsory for all schools to teach Health Education. Through these subjects, the DfE want to support all young people to be happy, healthy and safe and to be equipped for adult life and to make a positive contribution to society.
